ASBESTOS

Asbestos is a naturally occurring fibrous material that was frequently used in building construction materials between the 1950s and 1990's. It was used as an insulator (to keep in heat and keep out cold), has good fire protection properties and protects against corrosion.

Because asbestos is often mixed with another material, it's hard to know if you're working with it or not. But, if you work in a building built before the year 2000, it's likely that some parts of the building will contain asbestos.


Asbestos is found in many products used in buildings, including ceiling and floor tiles, pipe insulation, boilers, textured decorative coatings and sprayed coatings.

Asbestos is a hidden killer that can cause four serious diseases. These diseases will not affect you immediately; they often take a long time to develop, but once diagnosed, it is often too late to do anything. There is a need for you to protect yourself now.

If asbestos is in a good condition then it should not present a risk, however, if it is damaged or disturbed, people can inhale loose airborne fibres which may develop over the long term into diseases of the lungs and chest linings.

Non domestic building owners have a legal obligation to ensure people are not exposed to harmful asbestos on their premises and are legally required to carry out a risk assessment in relation to their property and to ensure that workers and visitors are not exposed to asbestos fibres.









According to the Health and Safety Executive (HSE), **asbestos is the greatest single cause of work-related deaths in the UK.** Illness from exposure to Asbestos Containing Materials (ACMs) can take 15 - 60 years to develop, therefore misleading those that may have inhaled asbestos fibres into thinking there is nothing wrong with their health.

The largest group of people at risk from asbestos-related disease is those in the building and maintenance trades. Most of the people that are dying now were exposed to asbestos in the 1950s, 60s and 70s.

There is no cure for asbestos-related disease and, every week on average, 4 plumbers, 20 tradesmen, 6 electricians, and 8 joiners die from the effects of this 'hidden killer'.

ARG SURVEYS LTD -

There is a legal requirement for building owners to carry out a risk assessment of their buildings. If a building was constructed or refurbished between 1950 and 1980, there is a high probability that asbestos materials have been used in the construction process. Before any risk assessment can be carried out the risk must be determined and therefore an asbestos survey is essential.

ARG Surveys Ltd are UKAS Accredited and have been carrying out Asbestos surveys for over 15 years and in the past two years alone have carried out approximately 4000 surveys. All our surveyors hold the BOHS 402 certificate and attend their annual refresher course each year to ensure they are competent in carrying out surveys in line with HSG264.



Property Acquisition

Before you purchase a property, ARG Surveys Ltd advises an asbestos management survey before the exchange of contracts. Along with the survey ARG can also provide an estimated cost of asbestos removal if required. This cost can influence the purchase price of the property. This asbestos survey ensures any financial implications, are acknowledged before the purchaser becomes the duty holder.

Contaminated Soil

Our surveyors can also sample contaminated soil and plan with you how to remove, treat or monitor all Asbestos Containing Materials (ACM'S) in accordance with the Control of Asbestos Regulations 2012.

ASBESTOS, DO YOU KNOW THE RULES?

DUTY TO MANAGE

The duty to manage asbestos in buildings is contained in Regulation 4, of The Control of Asbestos Regulations 2012, requires the person who has the duty (i.e. the "dutyholder") to:

- take reasonable steps to find out if there are materials containing asbestos in non-domestic premises, and if so, its amount, where it is and what condition it is in;
- presume materials contain asbestos unless there is strong evidence that they do not;
- make, and keep up-to-date, a record of the location and condition of the asbestos containing materials - or materials which are presumed to contain asbestos;
- assess the risk of anyone being exposed to fibres from the materials identified;
- prepare a plan that sets out in detail how the risks from these materials will be managed;
- take the necessary steps to put the plan into action;
- Periodically review and monitor the plan and the arrangements to act on it so that the plan remains relevant and up-to-date; and provide information on the location and condition of the materials to anyone who is liable to work on or disturb them.

ARE YOU A DUTY HOLDER?


Do you have clear responsibility for the maintenance or repair of non-domestic premises through an explicit agreement such as a tenancy agreement or contract?

Is there a tenancy agreement or contract? It may not specify who has responsibility for the maintenance or repair of non-domestic premises. In these cases, or where the premises are unoccupied, the duty is placed on whoever has control of the premises, or part of the premises. Often this will be the owner.

The main purpose of an Asbestos survey is to make the duty holder and others aware of the locations of asbestos within a building to ensure the safety of employees, contractors and the general public.

There are two types of survey for asbestos containing materials (ACM's) and the Duty-Holder, building owner, employer and surveyor need to be clear on the type of survey needed, where the survey is needed, and what records should result.

Management Survey - required to assess the types and condition of any ACM during the normal occupation and use of premises.





ARG's surveyors are experienced in surveying all types of premises, When a material is suspected of containing of asbestos, a bulk sample is taken and a risk assessment is recorded at the time, thus determining (via a pre-determined points scoring system) whether (if asbestos) the material requires removal, repair or managing. All bulk samples are deposited with an independent UKAS accredited laboratory for analysis and certified with a written report.

The findings of Asbestos Surveys are incorporated into a document known as an **Asbestos Register**. The register documents the location of known asbestos within a building and should always be available on site for inspection and made available to contractors before the start of any works.

Following the completion of the survey our team are able to offer advice and recommendations in conjunction with the risk assessment. Our expertise in working with asbestos will save you time, provide peace of mind, and ensure the most cost effective solutions are found to meet the current regulations.



The facility operates on dry recyclables delivered to a receptions area. The dry recyclables are processed at the facility on site where the materials are sorted by type and grade Paper, card, metals, Wood, Electronics, and Oil.

These materials are then baled prior to dispatch to agreed re-processors where they are used in the manufacture of secondary materials.

ARG in partnership with the Trust see the recycling and use of secondary materials plays an important role in controlling climate change and reduces the pressure on the Earth's natural resources
